

MAIN STREET TOUR OF HELL EVENT

WAIVER, ASSUMPTION OF RISK & RELEASE OF LIABILITY

This Waiver applies to each individual participating in Main Street Church of God's Tour of Hell (the "Event"). **"Released Parties"** means Main Street Church of God and its pastors, officers, employees, volunteers, representatives, and agents.

Participation, Age, and Health. Participation is voluntary, and participants must be at least twelve (12) years old. Each participant age eighteen (18) or older must sign a separate Waiver. A parent or legal guardian must sign for each participant under age eighteen (18), who must attend with a parent, legal guardian, or adult chaperone authorized by the minor's parent or legal guardian. I confirm that I, or the minor participant, can participate safely and accept responsibility for determining whether any physical, medical, respiratory, sensory, psychological, or other condition makes participation inappropriate.

Acknowledgment and Assumption of Risks. I understand that the Event is a dark, theatrical walk-through experience. Risks include darkness, uneven surfaces, stairs, confined spaces, crowds, theatrical smoke or fog, flashing or strobe-style lights, loud noises, sudden scares, actors in close proximity, emotional distress, respiratory or sensory reactions, slips, trips, falls, contact with people or objects, and other known or unknown risks. I knowingly and voluntarily assume all risks associated with participation, including risks arising from acts or omissions of other participants, visitors, or the Released Parties. I understand that I may choose not to enter or may ask to leave the Event.

Release of Liability. TO THE FULLEST EXTENT PERMITTED BY KENTUCKY LAW, I release and discharge the Released Parties from all claims, demands, causes of action, damages, losses, costs, or expenses arising from injury, illness, death, or property damage connected with my participation, or the minor participant's participation, in the Event, **INCLUDING CLAIMS CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF A RELEASED PARTY.** This release does not apply to willful or wanton misconduct or liability that cannot legally be waived.

Indemnification. To the fullest extent permitted by Kentucky law, I agree to indemnify and hold harmless the Released Parties from third-party claims arising from my acts, the minor participant's acts, or a failure to follow Event rules or staff instructions. This does not require indemnification for willful or wanton misconduct or liability that cannot legally be shifted.

Medical Assistance. In an injury or medical emergency, I authorize the Released Parties to obtain or provide customary first aid, transportation, and emergency medical assistance for me or the minor participant. This authorization creates no duty to provide such assistance, and I accept responsibility for resulting expenses.

Severability. If any provision of this Waiver is invalid or unenforceable, the remaining provisions will remain in effect to the fullest extent permitted by law.

Acknowledgment. I have read and understand this Waiver, understand that it affects legal rights, **have had the opportunity to ask questions**, and sign it knowingly and voluntarily. If signing for a minor, I consent to the minor's participation and agree for myself and, only to the extent permitted by Kentucky law, on the minor's behalf.
